No.A.49011/2/2012 - LE&IT/603: In exercise of the powers conferred by Section 112 of the Factories Act, 1948, the State Government is pleased to make the following rules to amend the Mizoram Factories Rules, 2014 namely:

1. Short title and commencement -

- These rules may be called the Mizoram Factories (Amendment) Rules, 2018. (1)
- They shall come into force on the date of their publication in the Official Gazetted. (2)

2. Amendment of rule 7 (1) -

In sub-rule (1) of rule 7 of the Mizoram Factories Rules, 2014 herein after referred to as the Principal rules the words "for a period of one year or five years, as may be requested in the application for registration and grant of license and on the payment of the fees specified in sub-rule (2)" shall be substituted by the words "for a period of ten years and on payment of the fees specified in the sub-rule (2)".

3. Amendment of Rule 8:

In sub-rule (4) of rule 8 of the Principal Rules, the words "fifty Rupees" shall be substituted by the words "hundred rupees".

4-Amendment of Rule 9-

In sub-rule (2) of rule 9 of the Principal I Rules, the words "one year or five years as the case may be" shall be substituted by the words "ten years".

- 5. Amendment of Rule 12 In rule 12 of the Principal Rules, the words "rupees twenty five" shall be substituted by the words "hundred rupees".
- Schedule I of the Principal Rules shall be substituted as 6. Amendment of Schedule - I follows, namely:-

"Fees for grant of License for a factory for one to five years.
